

AZ EAST VALLEY JUNIORS @ HOME COURTS CLUB PARTICIPATION AGREEMENT

I/We the parents/guardians of _____ have received the Parent/Player Handbook concerning the policies and rules and regulations of the AZ East Valley Juniors Volleyball Club @ Home Courts (hereafter called the "Club").

I/We agree, that our daughter having been selected to a team, that I/we will let her join the Club for this season. We also understand that we are responsible for all fees due at the specified due date (by the 7th of each month) as well as transportation for our daughter to practices and to at least one tournament per month (tournaments start in December/January).

I/We and our daughter understand and agree that selection to and maintaining a position on a specific team is at the discretion of the coach and club administrator. Promotions and demotions are possible depending on the development of the individual player including her commitment, coachability, behavior, etc.

NOTE: If your daughter is placed on a travel team, traveling is MANDATORY! A player on a traveling team will NOT be allowed to participate with any other organized team during the club season for purposes of traveling out of the country within the club season.

I/We agree that if for any reason our daughter does not abide by the rules and regulations of the Club or USA Volleyball, the Club has the right to remove her from the program. These rules are basic:

1. Caught with or use of drugs or alcohol.
2. Using abusive language.
3. Being arrested for any offense.
4. Stealing or destruction of property.
5. Not following the rules/instructions given by a coach.

I/We have read all the materials provided and understand the time commitment involved in practice and in competition. **We have reviewed the Fee Schedule on the Information Sheet and I/we understand that all fees must be paid in full, regardless of the duration of participation by the individual.** I/We understand that participation in the Club is limited, and that others were denied a position by our acceptance of a position on a team in the Club. Adjustments will be made to the extent possible in the event of injury of a player.

I/We agree to pay all fees per the Fee Schedule determined by the team our daughter is selected for. I/We understand that a non-refundable deposit is due the day of tryouts if our daughter is selected for the program. Monthly fees are due the first practice of the month and no later than the 7th of the month. A late fee of \$25 will be assessed if the payment is not in the payment box at the gym by the end of the night on the 7th of the month. Credit cards will be accepted. Please refer to the Parent/Player Handbook for proper check labeling. If the dues are not paid, I/we agree to pay any collection costs and attorney fees incurred on behalf of the Club to collect unpaid dues.

Having read the aforementioned items and the handbook of the Club and having discussed them with my/our daughter, we agree to abide by the rules of the Club and will support her participation in the Club.
